Updates: Updates are available as automatic downloads

- Within the warranty period (30 days from installation)
- When a valid Support Agreement is in place (see: Support Agreements)

Development and Support:

- Standard hourly charge: \$231.00 Inc GST

- Other development or change requests for the software
 - Minor changes charged at hourly rate
